COURSE DESCRIPTION:

Observe children with disabilities, collaborate with pre-service speech-language pathology students and other multidisciplinary professionals and have a cultural and linguistic immersive experience in Sri Lanka.

About the setting

Sri Lanka is a multicultural and multilingual country. It has a rich history and heritage. Sri Lanka is a low-and middle-income country (LMIC). As it has been established, a majority of individuals with disabilities live in LMICs. The Department of Disability Studies is the only department in the country that has a training program for speech-language pathology and occupational therapy. The Ayati clinic is the university clinic that is part of the Department of Disability Studies. Currently, there are 11,000 children registered at the clinic who seek a variety of clinical and educational services. All services provided through Ayati are provided free of charge. Students will have an opportunity to observe children with disabilities, to observe sessions conducted by pre-service speech-language pathology students and other multidisciplinary professionals, and to develop low-technology materials for these children. Additional excursions include popular sightseeing attractions to places that have historical and cultural importance.

Student Learning Objectives: Students will,

- 1. Describe speech therapy/communication/swallowing therapy sessions for individuals with communication disabilities living in a low-and middle-income country (LMIC).
- 2. Describe the use of low-cost therapy intervention material with individuals from culturally and linguistically diverse backgrounds.
- 3. Identify the needs of individuals with communication disabilities living in a low-and middle-income country (LMIC).
- 4. Describe the cultural, historical and linguistic aspects specific to Sri Lanka.

*COURSE REQUIREMENTS

- A. Pre-Departure orientation: 5% of the grade. Post any thoughts/questions/concerns you have regarding this study abroad on the Discussion posts following your orientation. Deadline: TBD prior to departure.
- B. Attendance- 20% of the course grade. All activities including those on the itinerary are mandatory. Students must remain with the group during the entire travel period except when an exception is requested and approved by the instructor in advance of the tour departure.
- C. Journal 50% of the course grade. Based on the personal reflections and observations on the trip submit a day-to-day record of your experiences. Describe and provide reactions to the places and people that you encounter and how they challenge your view of the country and the ideals disability and its intersection with culture. This journal can be in the format of a Paddlet (with photos and text), a blog, vlog, or a podcast or other similar medium. Deadline: TBD
- D. Presentation -25% of the grade. Students will complete a presentation based on their experience of this study abroad opportunity. This will include presenting on both their clinical and cultural experiences. They will have options to choose where they would like to do their presentation (e.g., NYSSHLA etc).
